



## RULES AND REGULATIONS REGARDING SECURE BICYCLE PARKING FACILITIES

1. Registration for use of the **Bicycle Parking Facilities** is available during City business hours (Monday through Friday, 8:30 am to 4:30 pm) at **Service Centre**, 397 Queen Street. Payments can be made via cash, credit card, debit card or cheque. Secured bike spaces are available on a first come first served basis.
2. Access to the **Bicycle Parking Facilities** will commence on the first day of the month and cease at the end of the paid term. Access can be renewed at the end of the purchased term and will be subject to space availability.
3. The Secure Bicycle Parking fee is \$30.00+tax for three (3) months; \$50.00+tax for six (6) months, or \$80.00+tax for twelve (12) months.
4. **No refunds will be issued for any part of the term of purchase during which access is not used.**
5. Purchase of the **Bicycle Parking Facilities** Access is a guarantee of a parking space in the secured **Bicycle Parking Facilities** area. Access to the **Bicycle Parking Facilities** is for one bike only per access designate. Access will be by use of a swipe card. The **Bicycle Parking Facilities** is for bicycle parking only. Please lock your bikes with a personal bike lock.
6. The **Bicycle Parking Facilities** is open 24 hours per day, seven days per week. On-site emergency numbers are posted in each facility – (506)999-2934 or (506)999-3061.
7. Access to the **Bicycle Parking Facilities** may be revoked or renewal refused for failure to comply with the regulations of the **Bicycle Parking Facilities**. **Access is non-transferable.**
8. Do not leave personal belongings in the facility. The City of Fredericton is not responsible for loss and/or damage of any kind whatsoever to bikes, bicycle equipment or personal belongings however caused. Cyclists must use the **Bicycle Parking Facilities** at their own risk.
9. All signage must be observed and obeyed. Do not block the general flow of traffic.
10. Abandoned bicycles or items left for 48 hours or more in the **Bicycle Parking Facilities** will be removed and stored for 14 days. After this time, they will be disposed of.

### **Follow these recommendations to deter theft:**

- ◆ **Use a secure bicycle lock to lock your bicycle to the rack (preferably a u-type lock).**
- ◆ Remove any detachable items including your bicycle seat and saddlebags and take them with you if possible.
- ◆ Personalize bicycle with stickers, decals, lights and other equipment.
- ◆ Present your bicycle to the Fredericton City Police station (front desk) during business hours Mon - Fri, 8:30 a.m. - 4:30 p.m. for engraving and registration in the City Police Bicycle Registration Program.

**Employees at the front desk of the City of Fredericton Service Centre are not responsible for the secure bike parking facility and are not able to provide access to the facility but can arrange to direct your concern to appropriate staff.**
