Vulnerable Person	
Definition	Any person having mental acuity deficiencies wherein the person cannot appreciate their surroundings and recognize the inherent dangers of environmental circumstances they find themselves in; any elderly person who is not medically diagnosed with a form of dementia, but by virtue of a mental infirmity causes him/her to wander and is a safety danger to themselves or others.
Examples	Alzheimer's Disease, Dementia, Parkinson's, Autism Spectrum Disorder, Acquired Brain Injury etc. Not all persons afflicted with these conditions need be registered – only if the caregiver or family member believes that their condition affects their cognitive ability AND they may pose a danger to themselves or others.
